**DESCRIPTION:** Development of approximately 50 affordable homes, landscaping and associated

infrastructure.

LOCATION: Land South Of Two Hedges Road, Woodmancote, Cheltenham

Thank you for consulting the Cotswolds Conservation Board ('the Board') on this proposed development, which would be located in the setting of the Cotswolds National Landscape.<sup>1</sup>

In reaching its planning decision, the local planning authority (LPA) has a statutory duty to have regard to the purpose of conserving and enhancing the natural beauty of the National Landscape.<sup>2</sup> The Board recommends that, in fulfilling this 'duty of regard', the LPA should: (i) ensure that planning decisions are consistent with relevant national and local planning policy and guidance; and (ii) take into account the following Board publications:

- Cotswolds Area of Outstanding Natural Beauty (AONB) Management Plan 2018-2023 (link);
- Cotswolds AONB Landscape Character Assessment (<u>link</u>) particularly, in this instance, with regards to Landscape Character Type (LCT) 2 (Escarpment) and LCT 7 (High Wold);
- Cotswolds AONB Landscape Strategy and Guidelines (<u>link</u>) particularly, in this instance, with regards to LCT 2 (link), including Section 2.1, and LCT 7 (link), including Section 7.1;
- Cotswolds AONB Local Distinctiveness and Landscape Change (<u>link</u>);
- Cotswolds Conservation Board Position Statements (<u>link</u>) particularly, in this instance, with regards to the Development in the Setting of the AONB Position Statement (<u>link</u>), and the Tranquillity Position Statement (<u>link</u>).

An assessment should be undertaken of the potential percentage increase in traffic movements on roads within – and on the boundary of - the Cotswolds National Landscape resulting from the proposed development, in line with Section 4.5 of the Tranquillity Position Statement. This should include an assessment of traffic movements on the B4632 and on the minor roads between Woodmancote and Cleeve Hill.

Great weight should be given to the potential impact of the proposed development on views from the Cotswolds National Landscape (in line with relevant case law, as outlined in the 'Development in the Setting of the Cotswolds AONB' Position Statement). This is particularly significant given that views from the Cotswold escarpment (LCT 2) and the High Wold (LCT 7) are both 'special qualities' of the Cotswolds National Landscape and are 'key features' of these LCTs. In this regard, the potential visual effects for receptors at the following viewpoints should be assessed:
