# 1. Regional and National Activity

# <u>Protected Landscapes Partnership</u>

- Development of the new 'Protected Landscapes Partnership' continues. The partnership includes National Parks, AONBs, National Trails and Natural England, with funding and oversight coming from Defra.
- A Partnership Manager is now in post, and a Chair and EDI Champion are currently being recruited.
- The key workstreams of Green Finance, Nature Recovery and Equity,
  Diversity & Inclusion are being allocated funding over two financial years
  (2023/24 and 2024/25) to demonstrate the value-add of the partnership at a
  local (as well as national) level.

# Cotswolds Plus Local Visitor Economy Partnership

- Following the recent 'De Bois' review of England's destination management/ marketing organisations (DMOs), Visit England is moving away from engaging directly with the current 250+ DMOs and, instead, accrediting around 40 new Local Visitor Economy Partnerships (LVEPs).
- o To date, 15 new LVEPs have been launched.
- A potential new Cotswolds Plus LVEP, which covers the following DMO areas: Cotswolds Tourism, Forest of Dean and Wye Valley Tourism, Marketing Cheltenham, Visit Gloucester, Visit Gloucestershire, and the local authority areas of Stroud and Tewkesbury, has recently submitted its application to Visit England and a decision should be made in the next few weeks.
- I have been asked to Chair the Management Board of this LVEP, with its membership including:
