1. National and Regional Activity

Levelling Up and Regeneration Act

O John Mills' part-time secondment to the National Landscapes Association (NLA), to advise on the Levelling Up and Regeneration Act (LURA), is coming to an end. He devised a survey which was shared across all Protected Landscapes and, using the results, he is finalising a report to present to the NLA and all Lead Officers. The main purpose is to help identify the potential implications and opportunities of the 'seek to further' duty. The duty will have different implications across Protected Landscapes due to the varying statutory purposes of each designation. John co-led a workshop on this topic at the NLA conference (see below) with Ruth Larbey (NLA) and Tim Slaney (acting CEO Downs National Park).

New National Park Designation

At the National Trails UK conference in May the Nature Minister, Rebecca Pow, informed the audience that the 'front runners' to become the next National Park had been agreed with Natural England and would be announced imminently. The General Election was called very shortly afterwards and therefore this didn't happen. It is now a case of waiting to understand how the new government will take forward this ambition.

National Landscapes Association – annual conference

This year's conference was held at Harper Adams University, Shropshire from 3-5 July. The theme was "Changing Landscapes: Changing Minds". The host National Landscapes were: Shropshire Hills, Cannock Chase and Clwydian Range and Dee Valley. John Mills, Fred Constantine Smith and the Chief Executive represented the Cotswolds.
