KEY ACTIVITY (not included in other papers)

1. Regional and National Activity

Written Ministerial Statement

- A recent Ministerial Statement ('package of measures') included an announcement that there would be new legislation in the Levelling Up and Regeneration Bill to enhance management plans and placing a stronger requirement on partners to contribute to their delivery.

Protected Landscapes Partnership

- Following the appointment of the Protected Landscapes Partnership
 Manager, there are currently a number of Partnership roles being recruited:
 - Equity Diversity and Inclusion Lead (hosted by Natural England)
 - Nature Recovery Lead (hosted by Natural England)
 - Big Chalk Programme Lead (hosted by the NAAONB)
 - Evidence Co-ordinators x2 (hosted by Natural England)

Comprehensive Spending Review

- Defra has started a process to pull together a robust business case for Protected Landscapes in preparation for the next Comprehensive Spending Review (likely to be 2025). The three key principles are:
 - ✓ Ensure operational costs are met
 - ✓ Support and incentivise the delivery of government objectives –
 Nature / Climate / People / Place
 - ✓ Be evidence based and equitable

National Landscapes – brand rollout

 The national rebrand to National Landscapes will be launched on 22 November. All AONBs are now onboard.

NAAONB Conference

 The NAAONB Conference in Bath (4-7 September) was very successful, with record attendance. Thanks to Magda, John, Alana, Jennifer, Rowan, Lorna and Brendan for attending. Thanks also to Simon, Mark, Nicole, Becky and Mike for organising field trips and walks. The theme was *Invested and Investing In Our Landscapes*.

Cotswolds Plus Local Visitor Economy Partnership

 Since the last meeting, Visit England has approved the Cotswolds Plus Local Visitor Economy Partnership (LVEP).

- The Management Board has met twice and early progress, driven by the Executive Officers Group (representing the existing DMOs), is encouraging
- Thanks goes to James Webb and Becky Jones for supporting some of the key workstreams, and to Alana Hopkins for supporting the Management Board.

2. Team, Board Members and Volunteers

<u>Team</u>

- o Starters:
 - Olivia Blackwell has joined the team as a Farming in Protected Landscapes Farming Engagement Officer.
- Leavers:
 - Following the conclusion of the Support Services team review,
 Mandy Pressland (Finance and Operational Support Officer) has made the decision to accept a new role and has left the team.
- Vacancies:
 - Interviews for the Management Accountant vacancy have taken place and, at the time of this paper being written, no decision has been made.
 - A Programme Support Officer is currently being recruited internally.
 - A Farming in Protected Landscapes Admin Support role is being recruited externally.
- Simon Smith is now retained as an expert advisor for the Gloucestershire Local Nature Partnership as it develops the Local Nature Recovery Strategy for the County.
- The Moreton Show was another success this year; it was a whole team effort, including Voluntary Wardens, with Alana Hopkins co-ordinating the planning and delivery.
- The team had a volunteering day at Rodborough Common on 3 October. The day involved scrub clearance and a walk (with ice cream!). 18 people managed to get along – a great success.

- o Emma Sims (Wychavon DC) has joined the Board since the last meeting.
- David Powell (Chair of the Finance and Governance Committee) and Margaret Reid (Chair of the Cotswolds Trails and Access Partnership) have joined the Board as 'Co-opted' Members.
- The Secretary of State (SoS) didn't appoint any Members in this year's recruitment round; therefore the two vacancies will roll over to 2024.
- o Brendan McCarron (Parish Group 5) has left the Board and recruitment for his replacement is underway.
