# **WORKING GROUPS, STEERING GROUPS AND TASK & FINISH GROUPS**

## INTRODUCTION

The groups are focused on key areas of the Board's work. Each group has a lead officer, support officer and between 3-6 Board Members. These groups make recommendations and proposals that are presented to the Executive Committee for review and approval that may then be taken forward to the Board for adoption.

## 1. CHANGES TO MEMBERSHIP

If the proposed changes to the terms of office for Executive Committee membership are approved (item 5), one of the potentially negative impacts will be that some of the other Board Members may feel their own opportunity to be involved will be limited for a longer period. To help overcome this it is proposed that priority for membership of Working Groups is given to individuals who aren't currently serving on the Executive Committee, thereby giving greater opportunity for other Board Members to become more involved in the wider work of the organisation.

In the event that not enough Board members put themselves forward to be on a particular working group then positions will open up to those individuals serving on the Executive Committee.

In any event, the Board should continue to encourage individuals, including Executive Committee Members, to attend meetings as interested observers and/ or technical experts, where required.

Lead officers and Board Members should also be encouraged to identify external specialists to join the groups, if deemed appropriate.
