PRIORITY ACTIVITY SINCE THE LAST MEETING (not recorded in other papers)

1. Team

- Ann Wyatt and I met with Patrick Arran, to discuss the role of Monitoring Officer for the Cotswolds Conservation Board. We will be seeking formal Board adoption to appoint Patrick at the AGM in June.
- John Mills was invited to join the Planning Advisory Group, a national group made up of representatives from Defra, Natural England, National Parks and AONBs. Their remit includes advising on the planning related proposals from the Landscapes Review and reviewing how national planning policies will impact national landscapes in England.
- Media attention and public engagement with the Kingfisher Trail has been excellent, ahead of its launch at the end of May. Visit Gloucestershire is the trail's headline sponsor.
- The Rural Skills programme has restarted with participation numbers and feedback being very positive. Courses are now bookable via our main website.
- The Voluntary Wardens are restarting guided walks over the next two months, the first time since the start of the pandemic began.
- The team will have a phased return to some office-based working from July.
